

**Special Called Meeting**  
**Repeal of Ordinance 2020-007**  
**First reading FY21 Fiscal Year Budget**

**Call to Order** – Mayor Dorman, who also did an official roll call of Council

Present were Mayor Mark Dorman and Council members Jody Connell, Michael Cook, Sonya Poole, Harvey Truesdale, Town Attorney Mitch Norrell, Town Administrator Mitch Lucas. Absent from the meeting was Council member Gail Rogora.

**Public Comment** – No Public Comment

**Reports/Updates**

- A. Mayor Dorman made a motion to repeal Ordinance 2020-07 changing the Fiscal year budget to a Calendar Year Budget Beginning January 1, 2021. The motion was seconded by Harvey Truesdale and the motion passed unanimously by a show of hands.
- B. Mayor Dorman made a motion to Re-Establish the Fiscal Year Budget for July 1, 2020 through June 30, 2021 (FY-21). The motion was seconded by Sonya Poole and the motion passed unanimously by a show of hands.
- C. Mayor Dorman made a Resolution strongly encouraging all residents to perform their patriotic duty by wearing face coverings in public places. This motion was seconded by Harvey Truesdale and passed in a 4 to 1 vote with Sonya Poole commenting she would like it to read strongly requiring a mask to be worn in public places.
- D. Eddie Coates submitted in writing his resignation as Councilmember at Large due to changes in his job. Mayor Dorman and other council members state how he would be missed after serving with Town Council for 19 years and wishing Mr. Coates the best in his future endeavors.
- E. There will be a special election to replace Eddie Coates position as Councilmember at Large. Time frame to sign up is July 24, 2020 thru August 3, 2020 at 12 PM.
- F. Mayor Dorman made a motion to add contractual historical artifacts to Executive Session. The motion was seconded by Jody Connell and the motion passed unanimously by a show of hands.

Mayor Dorman made a motion to enter into Executive Session. Mr. Connell seconded the motion and the motion passed unanimously by a show of hands.

**Executive Session**

A motion was made by Mayor Dorman and seconded by Jody Connell to return to open session. The motion was passed unanimously.

No action taken during Executive Session.

Motion made by Harvey Truesdale and seconded by Michael Cook to change the July Regular Session from July 20,2020 to July 27,2020. The motion was passed unanimously.

**Adjournment-** A motion was made by Harvey Truesdale, seconded Michael Cook to adjourn. Motion passed unanimously by a show of hands.
