- A. **Mayor's Report-**

Mayor Mark Dorman made a motion to have the official Town Celebration for Halloween on Saturday, October 30, 2021. However, that will not prevent celebrating Halloween on Sunday, October 31, 2021. Harvey Truesdale seconded the motion. The motion passed with a vote of 7-0.
