- E. **First Reading of Ordinance 2021-1 A Ordinance to adopt the complete Lancaster County Leash law ordinance-** Removed.
- F. **Report from Palmetto Management Solution concerning the Marion Boan Community Center Renovation Project -** Majority of the plumbing and painting is completed. The new lighting throughout the building is being done by Lime Energy and should be finished today or tomorrow. New flooring is to begin on January 25th. We have extended the kitchen in the Carolina Room. The main kitchen is now all behind closed doors, and more sanitary. The parking lot, both front and back is in the process of being resurfaced. At this point we are still under budget, but we still have some more work that needs to be done. Also, we have ordered 24 new lockers to go in the bowling alley. We are hoping to have everything opened and ready by mid-February or First of March.
