Three Dozen Trees Planted in Richards Park





The Town planted three dozen trees in Richards Park in January. The trees were made available by the Green Infrastructure Center (GIC) and Trees4SC. Employees of RiverNet dug the holes and the trees were planted by volunteers from OceanaGold, Dr. Jim Timmons of the local tree group working with GIC, GIC staff members and town employees. The trees include oak, cypress and ginkgo.

Town Offers Senior Garbage Rate

The Town is pleased to offer a senior garbage rate of \$12.75 per month for in-town residents age 65 and older. To qualify, the account must be in the name of the individual requesting the discount. The discount is available on residential garbage service only.

BUSINESS LICENSE REMINDER

Town of Kershaw Business Licenses are due by April 30, 2025. Any business, professional, contractor, subcontractor, or others conducting business within the corporate limits of the Town of Kershaw are required to have an annual business license. Licenses are due for renewal by April 30, 2025. If not paid by April 30, 2025, a penalty of 5% will be added each month. Failure to obtain a license can result in additional penalties as outlined in the Town of Kershaw Code of Ordinances. For further information contact the Kershaw Town Hall at 803-475-6065.
